## **COMMISSIONERS' MEETING MINUTES DECEMBER 14, 2016**

Commissioner Chairman Michael A. Baker called the regular meeting of the Indiana County Commissioners to order at 10:31 p.m. in the Commissioners Hearing Room.

#### **ROLL CALL**

Also in attendance were Solicitor Michael T. Clark, Chief Clerk Robin Maryai and others. Members of the news media present were Randy Wells, Josh Widdowson and Greg Reinbold.

#### **PLEDGE OF ALLEGIANCE**

Commissioner Baker led those present in reciting the Pledge of Allegiance to the American Flag.

#### **APPROVE MINUTES...NOVEMBER 30, 2016**

A motion was made by Ms. Hess, seconded by Mr. Ruddock and unanimously carried to approve the minutes of November 30, 2016 as submitted.

#### **PUBLIC COMMENT**

There was no public comment.

#### **EXECUTIVE SESSIONS**

There were no Executive Sessions.

## PROCLAMATION...HONORING THE CAREER AND LEADERSHIP OF DANNY R. SACCO

After a proclamation was read by Mr. Baker, a motion was made, seconded by Mr. Ruddock and unanimously carried to extend their sincere gratitude to Danny R. Sacco for his many decades of public service to all of the communities and residents of Indiana County and offered their best wishes to Danny Sacco as he enters a retirement well-earned and greatly-deserved.

#### **UNION CONTRACTS**

John Reilly, Labor Negotiator for the County, presented to the Board six tentative agreements that have been reached with the various unions, one memorandum for healthcare with Indian Haven and memorandum with the sergeants at the jail. The contracts are three year agreements that begin January 1, 2017. All provide for wage adjustments of 2% in 2017, 2.25% in 2018 and 2.50% in 2019. The agreements also call for changes in the healthcare plan with increased deductibles and copays. The county is also offering a second healthcare plan with a smaller network with smaller premiums. Mr. Reilly also explained that negotiations with Highmark capped the increases at no more than 5.5% over the next three years. It is noted that the employee contribution towards healthcare is 10% and the second plan will be 8%.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the contract with AFSCME (Courthouse) covering 63 employees.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve a partial agreement with AFSCME (Indian Haven) for the healthcare changes only.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the contract with ICAPE covering 16 employees.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the contract with UMWA (Jail) covering 70 employees.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve a memorandum of agreement with the sergeants at the jail covering 5 employees. It is noted that they are a meet and discuss unit.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve UMWA (Court related-clerical) covering 17 employees.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve an arbitration award with the Detectives covering 2 employees.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the contract with the Deputy Sheriff's covering 14 employees.

Mr. Reilly said two contracts with PSSU are pending and is hopeful they will be completed by the end of the year.

The Commissioners thanked all those involved in settling these contracts.

#### PURCHASE...LINK COMPUTER CORPORATION / INFORMATION SERVICES

At the request of Eric Leonard, Information Services, a motion was made by Mr. Baker, seconded by Ms. Hess and carried unanimously to approve the purchase of a server including three years of maintenance from Link Computer Corporation in the amount of \$32,850.00. This server will replace nine existing servers throughout the county that are near the end of their life. Since the fiber has been placed, communication between buildings can be done on site at the courthouse including backup. The replacement of this one server will save the county approximately \$180,000.00 in lieu of replacing each service at the cost of \$20,000.00.

#### CONTRACT...GILMORE / TRAGUS LLC / EMA

At the request of Thomas Stutzman, Director of Emergency Management Agency/911, a motion was made by Mr. Ruddock, seconded by Ms. Hess and unanimously carried to approve a contract renewal with Gilmore / Tragus Strategies, LLC as a grant writing consultant to the Emergency Management Agency for the period of February 1, 2017 to January 31, 2018 in the amount of \$60,000.00 payable in monthly installments of \$5,000.00. The motion also includes authorization for Commissioner Baker to sign on behalf of the county.

## GRANT APPLICATION...EMERGENCY MANAGEMENT PERFORMANCE GRANT / EMA

At the request of Thomas Stutzman, Director of Emergency Management Agency/911, a motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the FY 2017 grant application in the amount of \$84,405.29 for funding of EMA staff positions. This grant provides for reimbursement of up to 50% of the total amount for staffing of the Director and Deputy Director's salary and benefits. The motion also includes authorization for Commissioner Baker to sign on behalf of the county.

#### CHANGE ORDER #1...TYLER TECHNOLOGIES / EMA

At the request of Thomas Stutzman, Director of Emergency Management Agency/911, a motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve Change Order #1 with Tyler Technologies removing a Date File Conversion that was completed by EMA staff in the amount of \$31,400.00.

#### CHANGE ORDER #1...TYLER TECHNOLOGIES / EMA

At the request of Thomas Stutzman, Director of Emergency Management Agency/911, a motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve Change Order #2 with Tyler Technologies adding the purchase of Custom Software Interface that will add call export to Third Party RMS Interface in the amount of \$21,600.00.

The overall impact of these two change orders will have a savings of \$9,800.00 on the overall contract price.

### CHILD ACCOUNTING AND PROVIDE SYSTEM (CAPS) VERSION 13 UPGRADE / CYS

At the request of Holly Moyer-George, Children & Youth Agency, a motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the Child Accounting and Profile System (CAPS) Version 13 Upgrade. This upgrade is shared by fifty-five CAPS counties. The total cost of the upgrade is \$208,400.00 and is proportionally allocated across the all counties based on the number of users in each county. The cost of the upgrade to Indiana County is \$2,555.17.

#### PRIVATE PROVIDER AGREEMENTS FY 16-17 / CYS

At the request of Holly Moyer-George, Children & Youth Services, a motion was made by Ms. Hess, seconded by Mr. Ruddock, and unanimously carried to approve a Private Provider Contract with VisionQuest National, Ltc, Tucson, AZ for FY 2016-2017 to provide services to Children & Youth Services and Juvenile Probation on an as needed basis. They provide placement services.
