BIDS...EMERGENCY MANAGEMENT BUILDING ADDITION (07092018) / EMA

Tom Stutzman, Emergency Management Agency, announced that on July 9, 2018 bids were opened for the Emergency Management Building Addition as follows:

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the low bid received from CNC Construction, Inc., Penn Run, PA as the General Contractor. CNC's Base Bid is \$464,00.00 with alternate #1 as a deduction of \$18,600.00 making the total \$445,500.00. The other bid received from Marmat, Inc. was in the amount of \$645,000.00 with an alternate #1 as a deduction of \$2,200.00 making the total \$642,800.00.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously carried to approve Change Order #1 in the amount of a deduction of \$29,540.00, thereby making the final contract amount \$415,860.00.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the low bid received from Baer Services, Johnstown, PA as the HVAC and Plumbing Contractor in the amount of \$121,200.00. The other bid received from Whitby Plumbing & HVAC was in the amount of \$170,000.00.

A motion was made by Ms. Hess, seconded by Mr. Ruddock and carried unanimously to Change Order #1 in the amount of a deduction of \$126,500.00, thereby making the final contract amount \$104,700.00.

A motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve the low bid received from paragon Electric, Penn Run, PA as the Electrical Contractor in the amount of \$55,300.00. The other bid received from Carlisle G. Sheesley & Sons was in the amount of \$70,500.00.

The overall cost of the project will be \$575,860.00 and will be paid from the General Fund.
