Special Instructions for Program Delivery, due to COVID-19

As you are all aware, the COVID-19 Global Pandemic has changed the way most business' have to operate, the Public Safety Academy is not excluded from this requirement. Due to the ongoing Spread of COVID in the Commonwealth, Indiana County Public Safety Academy is operating under a Guidance Document, approved by the Pa. State Fire Academy. As we proceed with delivery of programs on site or at your station, our staff and the students, guests, and observers all must adhere to these new rules of operation. For the protection and safety of everyone we are asking for your support.

Listed here are some bullet points to get you acclimated to the Guidance Document:

- #1 on your arrival at the class site, for every class session you are attending, and before unloading any materials, report to the Lead Instructor for a temperature check and completion of a Medical Screening Form.
- If you cannot pass the Medical Screening requirements to participate in the class you will be required to leave the training grounds, we will make notification to you and your department as to the reason for your need to leave the program.
- If you become ill during your time in class, report your medical condition to the Lead Instructor, Safety Officer or Medical Staff.
- Class size is limited to the recommendation of DOH/CDC by classification of county reopening phase (Red/Yellow/Green).
- Hand Hygiene is extremely important, soap and water, as well as hand sanitizer is available through our programs.
- When required, nitrile gloves will be provided for students and staff.
- Masks shall be worn at all times, unless higher levels of respiratory protection are needed for training (i.e. SCBA). Ear Loop disposable masks will be available and provided.
- Social Distancing will be enforced in the classroom and on the training grounds.
- Social Distancing applies to student PPE, SCBA and Personal Effects as well, maintain six (6) feet of space between your personal staging areas.

LOCAL LEVEL PROGRAM REGISTRATION INFORMATION

Most local level courses are offered in conjunction with the Pennsylvania State Fire Academy as the local Educational Training Agency (ETA). All programs are conducted at the Indiana County Fire Academy facility and do not include meals or course materials, unless indicated. For full course descriptions refer to the State Fire Academy Course Catalogue, Local Level Course Section.

The following policies apply to all programs offered by the Academy:

- 1. Students must meet the age requirement established by the State Fire Academy by the starting date of the program. Proof of age can be required and should be available upon request.
- 2. Students with facial hair will not be permitted to participate in programs requiring the use of breathing apparatus per PSFA standards.
- 3. Students will be required to provide their own classroom materials, personal protection equipment, including breathing apparatus, work clothes and safety equipment as required for the program.
- 4. **Students are required to provide proof that the prerequisite training has been completed**. This must be a copy of the prerequisite course certificate of completion or attendance.
- 5. Students will be notified by mail of specific course information upon registration. A minimum number of students shall be required for any program. Programs will be cancelled for programs not meeting the required safe minimums.
- 6. Site fees must be paid in advance to guarantee placement in the program and to take advantage of the discount price for the class. Site fees not paid by the first night of the class, will be invoiced at the regular price listed for the class. Site fees not paid by the completion of the course will delay receipt of certification by the student and will be subject to a monthly interest charge.
- 7. Site fees will be refunded if a program is canceled. If you are unable to attend a course after registration, your cancellation must be received prior to the first program date to guarantee a refund or to guarantee that you are not billed as a student of the class.
- 8. Certification documents will be provided through US mail to each student successfully completing a program. Time attendance records will be provided upon request.
- 9. Registration deadlines for all programs are <u>**TWO WEEKS**</u> prior to the listed starting date unless otherwise indicated on the course outline.
- 10. All students will be required to complete a release from injury form prior to beginning any program at the Indiana County Public Safety Training Academy.

SITE RENTAL INFORMATION
