<u>COMMISSIONERS' MEETING MINUTES</u> <u>MARCH 8, 2023</u>

Commissioner R. Michael Keith called the regular meeting of the Indiana County Commissioners to order at 10:30 a.m. in the Commissioners Hearing Room.

ROLL CALL

PLEDGE OF ALLEGIANCE

Commissioner Keith led those present in reciting the Pledge of Allegiance to the American Flag.

APPROVE MINUTES...FEBRUARY 22, 2023

A motion was made by Ms. Hess, seconded by Ms. Gorman, and carried unanimously to approve the minutes of February 22, 2023.

COVID UPDATE

Thomas Stutzman reported that the PADOH's weekly COVID case count for Indiana County, for the week ending March 1st, totaled 43, this is a decrease over the previous three week's totals. The CDC's COVID-19 Community Levels, through March 2nd, remain at the "LOW" rate category for Indiana and all surrounding counties. The PADOH reported three additional COVID-19 related deaths since the last meeting. This brings the total number of COVID related deaths in Indiana County to 395. The CDC continues to report increases in the rates of Bivalent Booster shots throughout the region. In the population of those 5 years of age and older, on average, in the six-county region, a 0.15% increase has been reported in last week's update. The PADOH Seasonal Flu cases in Indiana County for week 8, of 2023, ending February 25th, reported a total of 1,070 cases documented. The majority being Type A. Overall, COVID and Season Flu cases are decreasing week by week and vaccination rates continue to increase.

PROCLAMATION...20TH FAMILY FUN FEST

After a proclamation was read, a motion was made by Ms. Gorman, seconded by Ms. Hess and carried unanimously to recognize the Children's Advisory Commission and the Indiana Mall Management as they celebrate the 20th Annual Family Fun Fest on March 25, 2023.

PENNSYLVANIA 811 SAFE DIGGING MONTH

After a proclamation was read, a motion was made by Mr. Keith, seconded by Ms. Gorman and carried unanimously to proclaim April 2023 at "Pennsylvania 811 Safe Digging Month" in Indiana County and encourage all to visit the Pennsylvania 811 website at www.pa1call.org for information.

EQUIPMENT PURCHASE...CONTRACT HARDWARE & SUPPLY INC./ MAINTENANCE

At the request of Mike Yanity, Director of County Facilities, a motion was made by Ms. Gorman, seconded by Ms. Hess and carried unanimously to approve an equipment purchase from Contract Hardware and Supply Inc to upgrade all courthouse door locks to meet ADA requirements in the amount of \$74,127.14. This contract is the low-bid from three Co-Star vendors and funding will be provided from two grant through the County Commissioners Association of Pennsylvania.

PRIVATE PROVIDER AGREEMENTS FY 22-23 / CYS

At the request of Vicki Weaver, Children & Youth Services, a motion was made by Ms. Hess, seconded by Ms. Gorman and carried unanimously to approve an agreement with Pathways Adolescent Center, Oil City, PA for FY 22-23 to provide services to Children & Youth Services and Juvenile Probation on an as needed basis. They provide placement services.

<u>CONTRACT – ENVIRONMENTAL SERVICES/FORMER ALICE PAUL HOUSE</u> FACILITY / PLANNING

At the request of LuAnn Zak, Office of Planning & Development, a motion was made by Ms. Hess, seconded by Ms. Gorman and carried unanimously to enter into a contract agreement with Stiffler McGraw & Associates of Indiana for environmental services to be conducted at the former Alice Paul House facility. The contract award will be \$2,900.00 to provide testing for asbestos materials prior to start of demolition. The testing is necessary to comply with the National Emissions Standards for Hazardous Air Pollutants (NESHAP) requirements when undertaking demolition activities. The contract is funded by Act 13 Impact Fee funds.

AUTHORIZATION TO SELL REAL ESTATE / AIRPORT

At the request of Rick Fuellner, Airport, a motion was made by Mr. Keith, seconded by Ms. Gorman and carried unanimously to authorize the sale of 2.51 acres of land located at the Jimmy Stewart Airport and also to authorize the chief clerk to advertise for sealed bids.

EQUIPMENT PURCHASE...MOTOROLA SOLUTIONS / EMA

At the request of Tom Stutzman, EMA, a motion was made by Mr. Keith, seconded by Ms. Hess and carried unanimously to approve the purchase from Motorola Solutions 10 portable radios with accessories, update mobile radios and two updated control stations for the County Jail in the amount of \$62,209.24.

MAINTENANCE AGREEMENT CHANGE ORDER...MOTOROLA SOLUTIONS / EMA

At the request of Tom Stutzman, EMA, a motion was made by Ms. Gorman, seconded by Ms. Hess and carried unanimously to approve a change order to the maintenance agreement with Motorola Solutions. This agreement amends the 2025 to 2033 maintenance and System Upgrade Agreement, previously entered into by all nine ICORRS county partners. There are three specific items identified: 1. New language on terms and conditions. 2. Adding Nokia Service for network support. 3. Adding remote system reboot services for system failures. The cost associated with the change order is divided between all nine counties, on an annual basis, thereby reducing each counties share by the addition of the three new county partners.

GRANT ACCEPTANCE...JUVENILE COURT JUDGES COMMISSION GRANT IN AID / JUVENILE PROBATION

At the request of Jim Decker, Probation, a motion was made by Ms. Gorman, seconded by Ms. Hess and carried unanimously to accept the Juvenile Court Judges Commission Grant in Aid in the amount of \$81,668.00. This grant provides 70% of funding towards juvenile probation officers salaries.

GRANT APPLICATION...AOPC DISCRETIONARY GRANT / PROBATION

At the request of Jim Decker, Probation, a motion was made by Ms. Hess, seconded by Ms. Gorman and carried unanimously to approve the submission of a grant application for the AOPC Discretionary Grant for the Drug Treatment and Veterans Treatment Courts. These courts provide individuals who are either veterans or people dealing with drug and alcohol concerns a chance to have intensive treatment and supervision giving them a better chance to re-enter the community. If approved, Indiana County could receive up to \$10,000 per court.

EQUIPMENT PURCHASE...2KREW SECURITY & SURVEILLANCE / INFORMATION SERVICES

At the request of Eric Leonard, a motion was made by Ms. Gorman, seconded by Ms. Hess and carried unanimously to approve an equipment purchase from 2Krew Security & Surveillance a complete upgraded camera security system at the courthouse in the amount of \$173,620.00+. This purchase includes cameras, servers, and installation.

STUDENT AFFILIATION AGREEMENT...WEST VIRGINIA UNIVERSITY / CORONER

At the request of Jerry Overman, Coroner, a motion was made by Mr. Keith, seconded by Ms. Gorman and carried unanimously to enter into an agreement with West Virginia University to allow students to observe autopsies, providing clinical education and/or fieldwork for the students.

GRANT APPLICATION...LOCAL ASSISTANCE AND TRIBAL CONSISTENCY FUND

A motion was made by Mr. Keith, seconded by Ms. Hess and carried unanimously to approve a grant application for the Local Assistance and Tribal Consistency Fund in the amount of \$50,000.00 under the Americas Rescue Plan Act for FY 2023. This grant is a general revenue enhancement program that provides additional assistance to eligible revenue sharing counties. Indiana County is eligible because the county has received federal payments in lieu of taxes.
