Office hours are 8:30 a.m. to 4:00 p.m. Only for October 29th, the Voter Registration Office will be open until 5:00 p.m. The link is www.vote.pa.gov. 4. **VOTED ABSENTEE AND MAIL-IN BALLOTS**

Reminder that Voted ballots must be received no later than 8:00 p.m. on November 5, 2024. Ballots can be returned to Voter Registration Office through the US Postal Service or dropped off in person at the Courthouse. A drop box is available in the lobby from 8:00 a.m. to 4:00 p.m., Monday through Friday. Except for Saturday, November 2nd the courthouse lobby will be open from 10:00 a.m. to 1:00 p.m. and November 5th, the courthouse will be open until 8:00 p.m.

5. **PUBLIC TEST**

The Indiana County Board of Elections will conduct a test run of the ES&S DS200 Precinct tabulating equipment and the DS450 Central Count tabulating equipment to be used for the General Election of November 5, 2024. Said test will be on Friday, November 1, 2024 at 1:30 p.m. in the Commissioners Hearing Room, Courthouse, Indiana, PA.
