A motion was made by Ms. Hess, seconded by Mr. Ruddock and carried unanimously to approve the minutes of July 31, 2019.

PROCLAMATION...CHILD SUPPORT ENFORCEMENT AWARENESS MONTH

After a proclamation was read by Mr. Ruddock, a motion was made, seconded by Ms. Hess and carried unanimously to proclaim August, 2019 as Child Support Enforcement Awareness Month in Indiana County. The proclamation marks the 44th anniversary of the child support enforcement program. Darren Divido, Director of Domestic Relation Section, was present to accept the proclamation. Supervisors from DRS also present were Barbara Rado, Sue Fabin, and Charles Zelinsky. Mr. Divido said the proclamation serves to clarify the agency's mission and are proud of the job search program they have in place.

BUDGET REVISION – 2015 HOME PROGRAM CONTRACT / PLANNING

At the request of LuAnn Zak, Office of Planning & Development, a motion was made by Mr. Ruddock, seconded by Ms. Hess and carried unanimously to approve Budget Revision #1 for the 2015 HOME Program of the Accessibility/Modification Rehabilitation Program. The motion also authorizes Mr. Baker to sign all necessary budget revisions forms. The budget revision will adjust the allocated amounts between the budget line items to reflect actual program costs. The adjustment in the budgeted amounts is between the Project Delivery and the Moderate Rehab Costs line items. The Project Delivery will be decreased by \$25,100 from \$69,100 to \$44,000. The Moderate Rehab line item will be increased by \$25,100 from \$750,900 to \$776,000. The administration line item remains as originally allocated at \$30,000.

Attorney Force will be assigned as legal counsel to parents for dependency matters at the rate of \$1,750.00 per month.

Attorney Kayden will be assigned as legal counsel to parents for dependency matters at the sum of \$55.00 per hour not to exceed \$1,750.00 per month.
