

**SPECIAL PUBLIC MEETING TO SET THE SALARIES OF THE ELECTED
OFFICIALS FOR 2020 - 2023
NOVEMBER 28, 2018 6:00 PM.**

Commissioner Chairman Michael A. Baker called the Special Public Meeting for the purpose of setting the salaries of the Elected Officials order at 6:00 p.m. in the Commissioners' Hearing Room.

PUBLIC COMMENT

There was no public comment.

RESOLUTION...ELECTED OFFICIALS SALARIES FOR 2016-2019

The discussion began by Commissioner Baker considering 2.25% per year or the CPI whichever is higher. Commissioner Ruddock said over the last 10 of the 12 years we have tried to apply consideration of the CPI using the Northeast Urban Consumers Region. Currently for 2018 it is 2.24%. Commissioner Hess suggested a straight 2.25% increase with no tie to the CPI.

A motion was made by Ms. Hess, seconded by Mr. Ruddock and unanimously carried to approve the following Resolution:

**IN THE MATTER OF ESTABLISHING THE SALARY INCREASES
OF ELECTED OFFICIALS OF INDIANA COUNTY**

WHEREAS, the Commissioners of Indiana County have been given the authority to set the salary increases for County Row Officers (Commissioners, Coroner, Register of Wills, Recorder of Deeds & Clerk of Orphans Court, Prothonotary & Clerk of Courts, Sheriff, Treasurer, and Auditors) of Indiana County for the years 2020, 2021, 2022, and 2023; and

NOW, THEREFORE, BE IT RESOLVED AND THE INDIANA COUNTY BOARD OF COMMISSIONERS DOES HEREBY RESOLVE AS FOLLOWS:

Effective the first Mondays of January, 2020, 2021, 2022 and 2023 the salaries of the Commissioners, Coroner, Register of Wills, Recorder of Deeds & Clerk of Orphans Court, Prothonotary & Clerk of Courts, Sheriff, Treasurer, and Auditors will be increased by 2.25%.

RESOLVED AND ENACTED by a unanimous Roll Call vote of the County Commissioners at the Special Meeting, duly advertised, on November 14, 2018, as evidenced by the signatures of the undersigned Commissioners and attestation of the Chief Clerk.
